



increases take effect (proposed by the Constitution Committee) At the present time there is a specific direction in the Society's Bylaw that specifies a waiting period of two months between the time a change to the Society's membership fees is approved by the membership and the implementation of such a change. This means that a fee increase approved on July 1 cannot be implemented until September 1.

The Constitution Committee believes that the original intent of this provision was to provide adequate notice of such changes under a decentralized and outsourced membership processing system. Under the current system, the Society is in a position to implement a fee change much more quickly both on the eStore and through our control of the membership process.

On the advice of the Executive Secretary, the Constitution Committee therefore proposes that a By-law change be made to allow fee increases to take effect upon such schedule as may be deemed appropriate. An approprimembership applications "in transit." This will simplify administration and permit the Society to benefit more rapidly from any fee increases that may be approved.

# Proposed By-law Changes – Annual Meeting – May 2005

These proposed changes to the Society's By-law #1 were approved at a meeting of National Council on Saturday, February 26, 2005 (2005-

02-26) and will be presented for ratification at the Society's Annual Meeting to be held on May 22, 2005 (2005-05-22) in Kelowna, .

6.19 VACANCY OF AN OFFICE

(1) An elected office becomes vacant by reason of death, resignation, or removal under *Article* 6.198(1), *or if the* holder of the office ceases to be eligible to hold office under Article 6.04. In such case, another eligible member of the Society may be elected by special resolution of the Council to fill such vacancy for the remainder of the term of office. In the event that a position must be filled prior to the next regularly scheduled meeting of the Council, the Executive Committee may do so on behalf of the Council under Article 7.08(2). # Section 3. Proposal to explicitly allow official notices to be sent to members by other than postal mail.

Presently there is no definition in By-law #1 defining the methods that can be used to communicate (provide "notice") to our members. Traditionally, "notice" has been only by postal mail,

however today there are other lessexpensive options such as Internet email and this amendment gives the Society the flexibility to use email and other communication options.

Motion #3: That article 1.01 of Bylaw No. 1 be modified to add the following definition: "notice" means a notification delivered either in writing by hand, mail, facsimile, or electronically to the member's then-current address of record.

The newly formed **Task Force 21 Committee** made its first report at the February Council Meeting. The By-law changes in section 4 and section 5 were proposed by this Committee and approved by National Council.

Section 4. A change to the procedure for changing the membership fees and a change from a fixed distribution of membership fees between the Society and the Centres to a flexible distribution.

**a)** Procedure to change membership fees

Presently the membership fees are set entirely by the membership following a motion proposed by any individual member, with sufficient

notice, at any meeting of the Society. National Council has the responsibility of administering an annual budget approaching half a million dollars, yet under the present By-law #1 it has no input or authority to propose or set appropriate membership fees commensurate with the costs of servicing the membership. This proposal provides the National Council with the sole authority to set the Society's membership fees. b) A change from a fixed to flexible distribution of the membership fees between the Society and the Centres

Presently 60% of membership fees for members attached to a Centre are retained by the Society and 40% are retained by the member's Centre — a ratio that does not reflect the increased costs and greater number of member services taken on by the Society in recent years.

Some examples include: National distribution of the *Observer's Handbook SkyNews* bulk subscription Public liability insurance National membership renewal system

The Society has also had to bear the significantly increased costs of postage, publicliability insurance, employee salary increases,

etc., all without changing the Society share of the membership fees. Centres have had to provide less of these services while retaining the same share of the fee. It's time to adjust the ratio so that the funds available are more equitably shared and to make it easier to maintain the share at equitable levels as costs and services

change. Another byproduct of the fixed ratio is that fee increases are required to be



higher than necessary because the Society realizes

only 60% of the increase. In effect the Centres are provided with a fee increase that they may not require to support their operations.

It is important to note that Centres presently have the ability to set their own fees through either positive or negative surcharges. To protect the Centres from fee reductions, this proposal requires that any change in the fee

requires that any change in the fee distribution resulting in a reduction of the Centre portion of the fee would require adoption by special resolution (two-thirds vote) of National Council. Fees

for unattached members will remain at the full membership fee with the Society retaining 100% of the fee.

With these amendments, through the elected officers and Centre-elected National Council Representatives, members will still have democratic control over fees and the Society/Centre fee distribution; however, these decisions will be made by National Council, the body that has the responsibility for managing the affairs of the Society.

Centre practice in the use of basic surcharges (proposed by the Task Force 21 Committee) It has been realized that many (perhaps all) Centres that collect basic surcharges appear to use these surcharges in such a way that is contrary to By-law #1. Specifically, clause 3.07 (4) states that basic surcharges must be optional unless used only to provide services


directly related to member rights and/or to pay for meeting space for the Centre and Centre Council meetings. It should not presently be used, for example, to operate an observatory and at

the same time be mandatory.
As far as we are aware there are no Centres

As far as we are aware there are no Centres where the basic surcharge is optional. This is confirmed by the fact that the National Office membership-handling software (and the eStore)

does not support optional basic surcharges. There have been no complaints about this

#### **Astronomy Day 2005**





We had "exploration" tables set up for people to look at. These held a variety of objects suitable for kids and parents to touch and hold and experiment with. One table had an earth globe, lamp and a Styrofoam "moon" ball along with instructions from Skyways on how to create the phases of the moon and seasons. On another table we had a celestial sphere globe and pairs of magnifying lenses for building a simple refractor. We set up different types of telescopes around the room and put signage on them explaining how they worked. We also had homemade spectrometers on the tables for people to take a look at the different light fixtures with.

Wayne set up a scope with solar filter outside and provided an opportunity for solar viewing whenever the sun peeked through the clouds. Although the sun was visible intermittently, the moon did not make an appearance during the afternoon.

Maurice ran tours of the observatory. People really enjoyed looking at the 24" telescope and noticing how "homemade" it is. (It incorporates rail car wheels, giant pulleys, sewer pipe telescopes, farm silo dome, truck differential, etc.)

Several videos were shown on the wall using the data projector. The viewing area was 12'x12' so it really made an impression with the lights off and sound system cranked!

Part of the day was a "telescope workshop" where we invited people to bring their own scopes out and we would help them sort out how to use them. Only one lady actually showed up with scope in hand but she was extremely happy that we helped her out.

Annette, Hugh and Jim A. were kind enough to run the pop and chip concession stand to bring in some extra donations.

Luckily the weather cleared up around 21:30 and everyone enjoyed a nice view of the moon, Saturn, Jupiter and some globular clusters through the 24" scope and several smaller telescopes set up outside on the viewing pad.

All in all it was an excellent day with many people commenting on how great everything was and we should do it more often, etc. I believe we had about 110 people come out throughout the course of the day. This was excellent attendance considering the poor weather.








#### **May Starhop in Canes Venatici**

#### May Starhop in Canes Venatici


Star chart is from Sky Tools, North is up, West is to the right. Technical information is from Night Sky Observers Guide by George Robert Kepple and Glen W. Sanner and from Sky Atlas 2000 Companion by Robert A. Strong and Roger W. Sinnott

The **bold** numbers on the map correspond with each numbered star hop in the text. It is important to know your directions in the finder scope and telescope eyepiece. You can do this by nudging your scope in a known direction while looking in the eyepiece,

note in which part of the field the stars are appearing. That is the direction in which you were pushing your scope. You may have to do this with both finder and telescope eyepiece. Also knowing the true field of view of your eyepiece helps a lot. Usually a low power of 35x is one degree or more. To figure it out for your particular scope, eyepiece configuration divide the apparent field of the eyepiece by the magnification it gives you with the scope you are using. ie: True field = Apparent field divided by magnification.

To see all the galaxies in this tour, this star hop would probably be best done in late April, early May when there is no moon, because the next no moon period will be when we truly don't get astronomical darkness. However the brighter Messier galaxies may be seen without really dark skies.

- 1)Lets begin with the bright star Cor Caroli or Alpha CVn. This is a double of unequally bright yellowish stars that are fairly close together. They look good at low power. The primary is mag 2.9 while the secondary is mag 5.5 and separated by 19.4" at a position angle of 229 degrees or SW from the primary.
- 2) From Cor Caroli shift 5 degrees NW to Chara or Beta CVn. Center this star in your low power eyepiece. While looking in the eyepiece move the scope slowly 3/4 degrees NW and you should see galaxy NGC 4490 slide into view. Now increase the power. In my 8" SCT at 144x, I had an interesting view of two interacting galaxies. 4490 was very obvious and dimmer NGC 4485 was situated just N of the W end of it. You will need dark skies to see 4485. NGC 4490 is about 27 million ly away.
- **3)** Our next target, **2CVn**, forms the west end of a "V" formed with Beta and 6CVn. This is a remarkable double star consisting of a fairly bright mag 5.8 yellowish primary and a dim mag 8.1 blue secondary close by on the west side. Separation is 11.4" at a PA of 260 degrees. This looked good in my scope at 57x.
- **4)** From 2 CVn use your finder to move your scope about 3 1/2 degrees NW to the fairly bright star 67UMa. Looking in a low power eyepiece, from this star shift your view slowly 1 degree east to find a thin sliver of a galaxy, **NGC 4111**. This sliver is small and oriented in a NW, SE direction. It is situated 4 'SW of a double star, where the dim secondary seems to point the direction to the galaxy. I liked the view at 144x in my 8" scope. You will need a dark sky to appreciate the view, but it is worth persevering for. NGC 4111 is about 37 million ly away.



- **5)** For the next target, follow the zig-zag trail of stars from Beta CVn to find **M106**, a large oval shaped galaxy oriented NW, SE. At 90x, this view looked cool, with the galaxy situated 1/2 degree west of a bright star. M106 is about 35 million ly distant.
- 6) Starting from Beta again, go to 6CVN and follow the star trail south to the double star on the map. Put your finder about 2 degrees ESE of the double and look in a low power eyepiece to see the impressive galaxy NGC 4631. At low to medium power you should be able to make out another dimmer galaxy, NGC 4656, 1/2 degree SE of 4631. There are four stars trailing off the east end of 4631, leading you to the area just north of 4656. NGC 4631 is approximately 28 million ly away and NGC 4656 is about 29 million ly.
- 7) Beta is our main jumping off point again for our next target. Slide about 3 degrees east of that star and in an 8x50 finder you may make out the galaxy **M94**. Going to your scope eyepiece, you should see a bright round galaxy at the right angle corner of a triangle formed with it and two stars.

Bump up the power for a nice view. M94 is 120,000 ly wide and is 33 million ly away.

- 8) This time look for the grouping of four stars that are located on the east end of the triangle that forms the constellation, or move 4 degrees NE of Cor Caroli to find them. From the northern star of this group slide about 1 1/2 degrees north to locate the **Sunflower** or **M63** galaxy. Once found, increase the power to about 100x. This is a large oval glow with two dim stars off the west end. M63 is 80,000 ly wide and 24 million ly distant.
- 9) From M63 use your finder to move 2 degrees NNE to the even double, go another 2 degrees further in the same direction to the single brighter star. Then you could probably go to your low power eyepiece and continue panning a further 1 1/2 degrees on the same bearing to watch M51or the Whirlpool galaxy slide into view. This is actually two galaxies, with much smaller NGC 5195 perched immediately on the north side. From dark skies and medium power I can just see the whirlpool structure in my 8" SCT. Our 24" club scope gives a nice view of the whirlpool structure.

  M51 is about 37 million ly away.
- 10) From Cor Caroli use your finder to pick up the loose grouping of stars about 3 degrees east. Put your cross hairs on the star that is indicated directly under the 10 on the map. Now look into a low power eyepiece and you will see that star as the almost right angle corner of a triangle formed with it and two galaxies. NGC 5005 is 1/2 degree west of the star and NGC 5033 is 1/4 degree south of that star. You may have to shift the star

to the east part of your field of view to be able to see the whole triangle. This scene sits in a field of widely spaced conspicuos stars. NGC 5005 is fairly bright despite its great distance of 47 million ly. NGC 5033 is 42 million ly away.



11) In your finder, follow the star hop east and south as indicated on the map to come to globular cluster M3, which should be visible in your finder as small round glow near some stars. Another way is to aim just under 1/2 way from Arcturus to Cor Caroli and fish around a little and you should be able to pick it up. I have done this with success several times. In my 8 " at 90x, M3 is bright and spectacular with lots of its outlying stars resolved and a dense glowing core in the center. The cluster is perched in the center of a right angle triangle of fairly bright stars. A neat scene it is. M3 is 220 ly wide and 48 million ly away from us.
