Observing and Small Telescope Maintenance Report – Blair

- More friction in the RA axis is required for Bob's 10" DOB to work properly.
- Dobsonian telescopes keep going out of collimation. Remove the main door threshold before moving the telescopes outside and then move them very carefully to/from the viewing deck. Additionally, don't store them pointing down.

Other Equipment Maintenance Report - Glen

- The Mallincam was out of focus. Focus is achieved by using the focuser hand pad. If focus cannot be achieved, adjust the focuser to 3.5 on the focuser dial using the handpad and then do a rough focus using the knob on the Celestron visual back. Fine adjustment can then be made with the handpad.

- Installed sensor controlled heat tape on the dome rotation motor and gear box.
