e. National Representative (Rob)

- The objective of the RASC board is to work towards a break-even year financially for 2023. We still expect a shortfall as in the budget, but the objective is to work towards zero deficit.
- Fee increases are being discussed again, but no decisions, just looking at ways to balance the budget. Future discussion on the observer's handbook is being contemplated
- Multiple corrections have been made in the accounting due to the way things were previously coded. We now have a person on staff looking after the accounting, and are transitioning away from hiring a second company. This may make the books look like there are additional costs in specific months as to what we expected. In the long run, this will make things much better.
- Budget process for 2024 has started, expect to be completed and signed off in January, once the final numbers are in for 2023.
- Observers' handbook was sent out for mailing on Friday.
- There was a loss to the number of members after the closure of sky news, but it seems to have bounced back now. Approximately 1000 people are new each year, and approx. 1000 no dot renew each year. (RW) I think it is too early to look at this number at this time.
- The current expenses sent out last week do not include the costs for printing and mailing the observers handbook.
- RASC has repaid \$40,000.00 of the COVID loan. The original loan was \$60,000, if repaid by the end of the year, the society only has to pay \$40,000. The same for Skynews. Both have been repaid ahead of schedule
- Up until now the directors have been concentrating on reducing costs. We are now at a place where there are minimal reductions available, the organization is now looking at ways to increase revenue including donations.
- Significant changes are being made to the procedures and processes at the office. This will provide better controls on spending and what/who is allowed to spend
- Some changes have been made to the National Council Terms and References. No changes to voting for members. Still one voting member per 200 members. Quorum is still at 50% of the centres wishing to send representatives +1.
- There are some questions as to how the Observers Handbook will be done in the future. Expect a survey to the presidents soon.
